Town Council Seats 3, 4 and 5 (2 year term) will be open for challenge in the Tuesday, March 8, 2011 Municipal Election. Seat 3 is currently occupied by Jay G. Foy; Seat 4 is currently occupied by Henry Lynch and Seat 5 is currently occupied by Mark C. Uptegraph.

Candidates must be a registered voter in the Town of Haverhill and a Town resident prior to time of qualifying. The Qualifying Period for candidacy for Town Council Seats 3, 4 and 5 will open promptly at 12:00 noon on Tuesday, January 25, 2011 and will close promptly at noon on Tuesday, February 8, 2011. Any person wishing to become a registered voter can complete an application form that can be obtained at the Haverhill Town Hall but must be received by the Palm Beach County Supervisor of Elections before the voter registration books close on Monday, February 7, 2011. Once registered, Voter Registration Cards are mailed to you from the Supervisor of Elections and reflect each voter's precinct and polling location for all elections.
