**BREAK DOWN**

Participants will be permitted to start breaking down on Saturday at noon. Please make sure your booth area is clean. **All equipment, supplies, empty boxes and trash MUST BE REMOVED FROM THE PROPERTY.** Anything not sold must be taken back with you.

**PARTICIPANT CANCELLATION**

**In the event of cancellation or late arrival by the Participant at any time, the Town of Haverhill shall have the right to rent the space to anyone else without obligation to return the payment and the right to retain such amount.**

**ITEMS AND PRODUCTS SPECIFICALLY PROHIBITED**

Games of chance, alcohol and tobacco products, firearms, ammunition knives and swords or weapons of any kind – whether being sold or distributed free – are strictly prohibited.
