

**RESOLUTION 2016-03**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF HAVERHILL, FLORIDA, ADOPTING A PRELIMINARY NON-AD VALOREM SPECIAL ASSESSMENT FOR THE 2016/2017 FISCAL YEAR FOR RESIDENTIAL PROPERTIES LYING WITHIN THE MUNICIPAL BOUNDARIES OF THE TOWN OF HAVERHILL AS MORE PARTICULARLY DESCRIBED IN EXHIBIT "A" ATTACHED HERETO, TO FUND SOLID WASTE COLLECTION AND DISPOSAL AND RELATED CHARGES WITHIN THE TOWN, COLLECTING SUCH PURSUANT TO THE UNIFORM METHOD FOR THE LEVY, COLLECTION AND ENFORCEMENT OF NON-AD VALOREM ASSESSMENTS, PROVIDING THAT SUCH ASSESSMENTS SHALL CONSTITUTE LEGAL, VALID, AND BINDING FIRST LIENS UPON PROPERTY AGAINST WHICH ASSESSMENTS ARE MADE UNTIL PAID; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Haverhill previously adopted Resolution 2010-10 on December 16, 2010 stating the intent of the Town to use the Uniform Method of Collecting Non Ad Valorem Assessment for solid waste collection and disposal and related charges within the Town; and

**WHEREAS**, after Public Hearing held on June 23, 2016, the Town Council has determined to adopt a preliminary non-ad valorem assessment roll for fiscal year 2016 - 2017 on the residential properties lying within the municipal boundaries of the Town as more particularly described in "Exhibit A", including all parcels of land annexed into the Town from the boundaries set at the time in Resolution 2010-10 into the future during the effective term of the resolution.

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF HAVERHILL, FLORIDA AS FOLLOWS:**

**Section 1.** The foregoing recitals are hereby affirmed and ratified as being true and correct.

**Section 2.** The Preliminary Non-Ad Valorem Assessment rates per computed parcels for the Town of Haverhill for the purposes of TRIM for the Fiscal Year 2015/2016 are hereby adopted as follows:

<b>Multi-Family Homes (&lt; 5 units)</b>	<b>\$ 234.00</b>

**Section 3.** This Resolution shall become effective immediately upon its passage and adoption.
