

RESOLUTION 2017-06

RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF HAVERHILL, FLORIDA, TENTATIVELY ESTABLISHING A MILLAGE RATE FOR THE 2017-2018 FISCAL YEAR; SETTING THE REQUIRED PUBLIC HEARINGS AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, each municipality must, prior to August 4th of each year, advise the Property Appraiser of its **proposed** millage rate, current year rolled-back rate computed pursuant to Section 200.065, Florida Statutes, and the date, time and place of the budget hearings; and

WHEREAS, in accordance with the above requirement, the Town must complete the necessary form, certifying taxable value, including statement of additions and deletions, for the Town of Haverhill; and

WHEREAS, based on preliminary figures necessary for the 2017-2018 fiscal year budget, the Town has calculated a **proposed** ad valorem millage rate.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF HAVERHILL, FLORIDA, as follows:

SECTION 1. The rolled back rate be certified at **4.2496** per thousand.

SECTION 2. That the **proposed** millage rate for 2017 - 2018 fiscal year be established at 4.5000 mills.

SECTION 4. That the first public hearing to consider the budget for the fiscal year 2016-2017 be held on Thursday, September 14, 2017 at 7:00 p.m., in conjunction with the first Council Meeting for the month of September 2017.

SECTION 5. That the second public hearing to consider the budget for the 2016 - 2017 fiscal year be held on Thursday, September 28, 2017 at 7:00 p.m. during the Regular Council meeting. Both the first and second public hearing shall be held in the Council Chambers, Town Hall, 4585 Charlotte Street, Haverhill, Florida 33417.

SECTION 6. That this information be included on the Certification of Taxable Value Form which is forwarded to the Property Appraiser and Tax Collector.

SECTION 7. This Resolution will become effective immediately upon its passage and adoption.

PASSED AND ADOPTED this 13^h day of July, 2016. Council Member Uptegraph offered the foregoing Resolution and moved its adoption. The Motion was seconded by Council Member Harvin and upon being put to a vote, the vote was as follows:


The Mayor thereupon declared this Resolution approved and duly adopted by the Town Council of the Town of Haverhill, Florida on this 13^h day of July, 2017.
