

RESOLUTION NO. 2017-09

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF HAVERHILL, PALM BEACH COUNTY, FLORIDA, LEVYING A TAX OF 4.5000 MILLS UPON THE TAXABLE NON-EXEMPT PROPERTY WITHIN THE TOWN OF HAVERHILL FOR THE 2017-2018 FISCAL YEAR RESULTING IN A 5.89 PERCENT INCREASE OVER THE ROLL BACK RATE OF 4.2496.

WHEREAS, the Town Council of the Town of Haverhill has heretofore determined the amount of tax revenues to be raised for all municipal purposes, and

WHEREAS, the Town Council of the Town of Haverhill has heretofore determined the amount of tax revenues to be raised does require a millage increase of over the rolled back rate of *4.2496 mills*, and

WHEREAS, the Property Appraiser has certified to the Town of Haverhill the total assessed valuation of all property within the municipal boundaries of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF HAVERHILL, FLORIDA, AS FOLLOWS:

SECTION 1.

The Town Council does hereby adopt its final millage rate of *4.5000* mills to be levied for the general fund upon all taxable nonexempt real and tangible personal property located within the boundaries of the Town of Haverhill, Florida, prior to adoption of its budget.

SECTION 2.

THE FINAL LEVY OF 4.5000 MILLS WILL RESULT IN A 5.89 PERCENT INCREASE OVER THE ROLL BACK RATE OF 4.2496.

SECTION 3.

This final millage rate of *4.5000* mills for the general fund is for the fiscal year commencing October 1, 2017 and ending September 30, 2018.

This Resolution shall take effect immediately upon passage.

PASSED AND ADOPTED this 28 day of September, 2017. Council Member Harvin offered the foregoing Resolution, and moved its adoption. The Motion was seconded by Council Member Plyler and upon being put to a vote, the vote was as follows:
