OFFICIAL MINUTES

The regular monthly meeting of the Haverhill Town Council was held on Thursday, August 9, 2018 at the Town Hall, 4585 Charlotte Street, Haverhill, Florida. Those present were Jay G. Foy, Mayor; Lawrence Gordon, Vice Mayor; Mark C. Uptegraph (arrived late), and Council Member; Remar Harvin, Council Member. Also present were John Foster, Town Attorney and Janice C. Rutan, Town Administrator.

CALL TO ORDER

Mayor Foy called the meeting to order at 7:05 p.m.

INVOCATION AND PLEDGE OF ALLEGIANCE

Mayor Foy offered the Invocation and led in the Pledge of Allegiance.

ROLL CALL

The Town Administrator called the roll. All members were present with the exception of Council Member Sohn. (Council Member Uptegraph arrived late).

APPROVAL OF AGENDA

A motion was made by Council member Harvin, seconded by Vice Mayor Gordon and unanimously passed (3-0) to approve the agenda as amended by removing the request for Special Exception to allow for an accessory dwelling unit as filed by Rose Slaymaker, owner of the property located at 792 Palo Verde as the applicants had not filed a proposed site plan as requested.

APPROVAL OF THE CONSENT AGENDA

Approval of the minutes of the July 12, 2018 Regular Meeting A motion was made by Vice Mayor Gordon, seconded by Council Member Harvin and unanimously passed (3-0) to approve the Consent Agenda as presented.

COMMENTS FROM THE PALM BEACH COUNTY SHERIFF'S OFFICE

The Palm Beach County Sheriff's office deputy addressed the Town Council. Stats for the previous 2 week period were reported on. There had been 340 calls to dispatch with 10% of those being crime related. On July 24, 2018 there had been 64 burglaries to vehicles in Palm Beach County including Haverhill neighborhoods. A task force had been formed and the juveniles responsible for the burglaries were arrested. Council and Staff expressed appreciation to the Palm Beach County Sheriff's office (specifically Districts 1 & 2) for making the arrests.

REGULAR AGENDA

Approve the request of the Criminal Justice Commission for the allocation of JAG funds for federal fiscal year 2017 (current fiscal year 2018) in the amount of \$322,513 to be used for the countywide Adult and Juvenile Reentry Programs.

The Town Administrator offered staff's report. She explained the Town Council was requested each year to approve the request of the Criminal Justice Commission for the allocation of FY 2017 (County Fiscal Year 2018) JAG funds. She explained that if Palm Beach County does not receive 51% support from the municipalities, representing 51% of the county's population, they would be unable to receive grant funding in the amount of \$322,513.

A motion was then made by Council member Harvin, seconded by Vice Mayor Gordon and unanimously passed (4-0) to approve the request of the Criminal Justice Commission for the allocation of FY2017 JAG funds to Palm Beach County in the amount of \$322,513 for the specified projects within Palm Beach County.

REPORTS

Town Attorney

Attorney Foster reported that he would be presenting proposed ordinances at the September Council Meeting.

Mayor

Mayor Foy reported that the recent plan selected by the Army Corp of Engineers benefitted only the Loxahatchee River and no other water bodies.

New NPDES requirements include all major outfalls having to be tested annually.

He reported that the District 2 & 3 luncheon had been moved to the Lake Worth Golf Course. The acoustics made it very difficult to hear anyone speaking, the food took too long to be served and the set up was not conducive to a roundtable discussion. Council Member Harvin reported that he had met with the owners of El Sabor Restaurant on Military Trail and they would be interested in hosting the monthly meetings. Council Member Harvin agreed to follow up with El Sabor and the Palm Beach County League of Cities..

Mayor Foy then presented the idea that the Town Council consider using the sales tax monies to pay for costs involved in bringing private roads up to Town standards as part of the MTSU program the Town had spoken about. A brief discussion followed.

Town Administrator

The Town Administrator suggested the Town Council schedule a Budget Workshop immediately preceding the next regularly scheduled Council meeting. She then

suggested the September Workshop be rescheduled to September 11, 2018 due to the Labor Day Holiday. Council agreed by general consensus.

Committee/Delegate Report

It was reported the Palm Beach League of Cities General membership meeting would be held at Sand Hill Crane Golf Course in Palm Beach Gardens.

UNFINISHED BUSINESS

The Mayor had presented a worksheet on the affordable housing units in the Town Of Haverhill. Discussion followed as to the methodology in determining workforce housing units and eligibility.
