The regular monthly meeting of the Haverhill Town Council was held on Thursday, September 13, 2018 at the Town Hall, 4585 Charlotte Street, Haverhill, Florida. Those present were Jay G. Foy, Mayor; Mark C. Uptegraph; Council Member and Remar Harvin, Council Member. Also present were John Foster, Town Attorney and Janice C. Rutan, Town Administrator.

CALL TO ORDER

Mayor Foy called the meeting to order at 7:15 p.m. immediately following the close of the first Public Budget Hearing.

COMMENTS FROM THE PUBLIC

None.

APPROVAL OF AGENDA

The Town Administrator requested the minutes of the August 23, 2018 Regular Meeting be removed from the Consent Agenda. A motion was made by Council Member Harvin, seconded by Council Member Uptegraph and unanimously passed (3-0) to approve the agenda as amended.

APPROVAL OF THE CONSENT AGENDA

Approval of the minutes of the August 9, 2018 and August 23, 2018 Regular Meeting and August 7, 2018 Workshop

A motion was made by Council member Uptegraph, seconded by Council member Harvin and unanimously passed (3-0) to approve the Consent Agenda as amended.

PRESENTATIONS

COMMENTS FROM THE PALM BEACH COUNTY SHERIFF'S DEPARTMENT

The crime statistics for the previous 2 weeks was addressed by the Palm beach County Sheriff's office. There had been 162 incidents created that included business checks, residence checks, domestic complaints and traffic stops. There had been no break-ins to either residences or cars. The problem area was the 7-11 on Military Trail where there had been 2 arrests including suspicious persons. He attributed the high police presence to the low crime rate.

The incident involving the 2 juveniles was handled by another department within the Sheriff's office.

The Town Council expressed their appreciation to the Palm Beach County Sheriff's office.

SECOND READINGS AND PUBLIC HEARINGS

Application for Special Exception to allow for an accessory dwelling unit as filed by Rose Slaymaker, owner of the property located at 792 Palo Verde.

The Town Administrator offered Staff's Report including the written recommendation of the Town Planner, Josh Nichols. Mrs. Slaymaker was present.

A motion was then made by Council Member Harvin, seconded by Council Member Uptegraph and unanimously passed (3-0) to approve the request for Special Exception to build an Accessory Dwelling

Unit adjacent to the principal dwelling unit as a stand-alone structure at 792 Palo Verde Court subject to the following conditions as recommended by Staff:

CONDITION #1: Exact location of the ADU shall be indicated on the site survey as submitted with the building permit application to verify setbacks, structure size and driveway location.

CONDITION #2: The applicant shall submit evidence of compliance with Palm Beach County Department of Health that existing septic system can adequately serve the proposed ADU.

Mrs. Slaymaker agreed to the Conditions of Approval.

Discussion at the luncheon included the new Westlake Community. Over 100 homes have sold. Universal Health Services would be building a health facility in Westlake.

The Palm Beach County EOC had been built to withstand a Category 5 Hurricane. It was unclear whether the South Florida Water Management Facility or the Lake Clarke Shores Police Department would withstand those conditions.
