I. CALL TO ORDER

Mayor Foy called the Workshop to order at 12:15 pm

II. PRESENTATIONS/PROCLAMATIONS

Kevin McGinley of Land Research Management, Inc. is here to speak on behalf of the owners of 4968 Cyprus Lane regarding change of land use for building purposes.
