FIRST READINGS AND REGULAR AGENDA

Consider proposed Solid Waste Collection Agreement (contract) between the Town of Haverhill and Waste Pro of Florida, Inc., for the 3 year period October 1, 2016 through September 30, 2019 with a three (3) year option to renew.

Attorney Foster presented Staff's report.

Mayor Foy noted for the record that the meetings held between the Contractor and Staff were ministerial in nature and were not to be considered negotiations.

Tim Bowers, present representing Waste Pro thanked the Town Council and Staff for the opportunity to work with the Town and noted Waste Pro had no issues with the proposed changes to the Contract between the Town of Haverhill and Waste Pro.

In response to Council's inquiry, Mr. Bowers noted he would have to determine approximate time of pick-up with Chris Schulle, Route Supervisor.

A motion was then made by Council Member Harvin, seconded by Vice Mayor Gordon and unanimously passed (4-0) to authorize the Mayor to sign the Solid Waste Collection Agreement between the Town of Haverhill and Waste Pro of Florida, Inc. for the ensuing three year period, expiring September 30, 2019, with a three year option to renew.

REPORTS

Town Attorney

Attorney Foster reported that he would have proposed Ordinances drafted for first reading November 17, 2016. The Town would need to update its Liquor Sales ordinance.

Mayor

Mayor Foy reported on an article in the Palm Beach Post regarding the opinion of the office of Inspector General that cited the City of Palm Beach Gardens for not recording negotiations during staff meetings with a proposed Contractor. Again, he noted for the record that no negotiations transpired between Staff and Waste Pro, they were merely meetings to clarify administrative contract issues.

Vice Mayor Gordon and Council Member Harvin had attended the Mayor's Literacy luncheon held at the Flagler Steakhouse at the Breaker's Hotel. This year, the Read for the Record would take place on October 27, 2016 and the book to be read was entitled "The Bear Ate Your Sandwich".

Discussion followed regarding the proposed RaceTrac gas station being planned for Southern Boulevard and Clearly Road. By general consensus, Council agreed to object to Palm Beach County land use amendments that will ultimately increase the flow of traffic along the thoroughfares that run through the Town of Haverhill. It was reported that there was contact made to residents in Town about selling their property for a potential gas station. The proposed WaWa gas station to be located on Belvedere Road, closer to the airport was next discussed.

Mayor Foy commented that he was looking forward to working with Waste Pro, and asked Vice Mayor Gordon to share the favorable information he had gathered on the Company prior to the award of the RFP.

Mayor Foy next reported on the FEMA FIRM maps that were presented. He would review and report back to Council.

He had attended the NPDES Steering Committee meeting. October 1, 2016 will begin the new period.

Town Administrator

The Town Administrator reported on the computer issues she had been experiencing. Essential New Solutions, the Town's contracted IT provider was working on repairs.

Committee/Delegate Report

Vice Mayor Gordon reported on the information meeting he had attended at the 211 Emergency home office earlier in the day. He was unaware of all the services 211 had to offer and was quite impressed with their operations.

It was reported that at the Palm Beach County League of Cities District II and II meeting, a discussion concerning telecommunication towers took place.

UNFINISHED BUSINESS

Director of Public Services, Joseph Roche reported that he and the Town Engineer, Todd McLeod would be attending a meeting of the LMS to discuss possible grant awards for the Park lane and Cyprus Road drainage improvement project.

The Town Administrator noted that the Town Planner would begin the design phase of the project in an effort to expend funds left in the current year budget.

NEW BUSINESS

The Town Administrator requested Town Council consideration for the appointment of the Oversight Committee should the referendum for the 1 cent sales tax initiative pass at the November 8, 2016 election. Council noted it preferred to appoint its own committee and not rely on the Committee appointed by the Palm Beach County League of Cities.

The Mayor clarified his preference for the additional mosquito sprayings specifically targeted for the Zica virus.
