Pursuant to the foregoing notice, the regular meeting of the Haverhill Town Council was held on Thursday, July 9, 2015 at the Town Hall, 4585 Charlotte Street, Haverhill immediately following the close of the Local Planning Agency Meeting. Those present were Jay G. Foy, Mayor; Jerry Beavers, Council Member; Lawrence Gordon, Council Member and Mark C. Uptegraph, Council Member. Also present were Town Attorney John Foster, Director of Public Services Joseph Roche and Town Administrator, Janice C. Rutan.

CALL TO ORDER

Mayor Foy called the meeting to order at 7:00 p.m.

INVOCATION AND PLEDGE OF ALLEGIANCE

Mayor Foy offered the Invocation and led the Pledge of Allegiance at the previous meeting.

ROLL CALL

The Town Administrator recorded all members present.

COMMENTS FROM THE PUBLIC

None.

APPROVAL OF AGENDA

The Town Administrator requested approval of the minutes be removed from the Consent Agenda. A motion was made by Vice Mayor Woods, seconded by Council Member Gordon and unanimously approved (5-0) to approve the agenda as amended.

APPROVAL OF THE CONSENT AGENDA

Approval of the minutes of the June 25, 2015 Regular Meeting.

COMMENTS FROM THE PALM BEACH COUNTY SHERIFF'S DEPT.

Deputy Strickland was present and presented the crime statistics for the previous 2 week period. He reported that the problems were strictly civil matters only.

He referred to a halfway house on Haverhill Road and a property on Park Hill that was on the down side of its issues.

Deputy Strickland requested the Town's assistance in reminding its residents to be sure they keep their homes and their vehicles locked at all times.

The Council expressed their appreciation to PBSO for the permit detail within the Town.

Daphne Burgan, New Parkview Place commented that persons were seen jumping the fence at Stacy Street into the subdivision and going to 1080 New Parkview Place. She added that the streets needed resurfacing.

Council responded that the Town would work with PBSO to be sure the area was patrolled. They explained the roads were private and resurfacing was the responsibility of the HOA. She responded the proposed cost of \$30,000 was unaffordable.

Mayor Foy recused himself from discussion of the matter explaining a possible conflict of interest.

The title was read by Attorney Foster. Attorney Foster also offered staff's report and informed Council that the Local Planning Agency had recommended Town Council approval of Ordinance No 430 on first reading.

A motion was made by Council Member Beavers to approve Ordinance No. 430 upon first reading. Vice Mayor Woods seconded the motion adding that the approval should include Staff's recommendations as outlined in the letter from Josh Nichols dated July 8, 2013 as well as the recommendation to approve from the Local Planning Agency. Council Member Beavers approved the amendment, and the motion passed 4 -0 in favor with Mayor Foy abstaining from the vote.

Attorney Foster reminded Council that the meeting of July 23, 2015 would be for the final reading of Ordinance No. 430, and for the approval of the site plan and product elevations.

<u>Tom Hudson, Club Road East.</u> Mr. Hudson inquired as to the site plan and if the housing would be similar to the Sunset Isles and Emerald Cove. A discussion then followed about the type product that would be constructed on the site, with D. R. Horton representatives assuring all it would be considered high end housing.

RESOLUTION 2015-03: A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF HAVERHILL, FLORIDA TENTATIVELY ESTABLISHING A MILLAGE RATE FOR THE 2015 - 2016 FISCAL YEAR; SETTING THE REQUIRED PUBLIC HEARINGS AND PROVIDING AN EFFECTIVE DATE The title was read by Attorney Foster.

Discussion followed. Vice Mayor Woods noted he would like to increase the Communication Services Tax, set the preliminary millage rate at 4.7500 and if the budget could be balanced at 4.5000, reduced the tentative millage to 4.5000.

The tentative millage could be reduced once set, but could not be increased.

Council was in agreement that it would like to pursue increasing the Communications Services Tax as a way to increase revenues. Council Member Uptegraph agreed the Town was running at a deficit with regard to infrastructure but was not in favor of increasing the millage above 4.5000 and expressed concern of even setting the tentative millage a higher rate as it could prove to be too much of a temptation to adopt. Council Member Gordon agreed.

<u>Tom Hudson, Club Road East.</u> Mr. Hudson inquired as to when they would break ground. The process was explained in detail.

A motion was then made by Council Member Uptegraph, seconded by Council Member Gordon and unanimously passed (5-0) to adopt Resolution 2015-03, tentatively establishing a millage rate of 4.5000 for the 2015/2016 fiscal year and setting the required public hearings.

BUDGET DISCUSSIONS

A brief discussion followed as to the proposed budget for the ensuing fiscal year. Attorney Foster has presented the AGO's opinion confirming the Town would not have to go out to bid under CCNA for the position of Town Engineer.

At the Atlantis luncheon yesterday approximately 29 people attended. Including members from the Sheriff's Department, law enforcement from Atlantis, Lake Clark shores, Commissioner Shelley Vana.

Jeff Hmara, from Royal Palm Beach attended the legislative meeting Orlando. Jeff discussed charter schools, relocation of utilities, and other issues. Dan Clark discussed growth management. Shelley Vana discussed Uber and Lyft the ride service, and panhandling. There was also discussion on the half cent sales tax.

I presented from my idea file an emergency vehicle device that would include fire rescue and law enforcement and any other emergency type vehicles.

Emergency vehicle device

When emergency vehicles respond to calls, drivers of vehicles do not hear sirens due to windows up, radio on, or conversation with other passengers. Emergency vehicles would be equipped with a transmitter that would broadcast approximately 500 ft. All other vehicles including emergency vehicles would be equipped with a receiver that is activated by the Emergency Vehicle Transmitter and. The receiver is a separate radio and could be self-contained with its own speakers. The transmitter would give location and direction of travel. This could be an after market installation and required on all new cars. Cars that have a high tech package would also show the location of emergency vehicles.

Shelley Vana said she liked the idea I was going to present it to the County Fire Chief.
