CALL TO ORDER

Mayor Foy called the meeting to order at 7:00 p.m.

INVOCATION AND PLEDGE OF ALLEGIANCE

Mayor Foy offered the Invocation and led the Pledge of Allegiance.

REORGANIZATION OF TOWN COUNCIL

Nomination for Mayor

COMMENTS FROM THE PUBLIC

Council once again expressed their appreciation to the Palm Beach County Sherriff's Office for their assistance in keeping Haverhill safe.
