TOWN OF HAVERHILL TOWN COUNCIL REGULAR MEETING Thursday, November 19, 2020 OFFICIAL MINUTES

The regular monthly meeting of the Haverhill Town Council was held on Thursday, November 19, 2020 at the Town Hall, 4585 Charlotte Street, Haverhill, Florida. Those present were Jay G. Foy, Mayor; Lawrence Gordon, Vice Mayor; Mark C. Uptegraph, Council Member; Dennis Withington, Council Member via teleconferencing) and Ray Caranci, Council Member. Also present were John Foster, Town Attorney and Janice C. Rutan, Town Administrator.

Teleconferencing was available for those persons wanting to participate in the meeting remotely.

CALL TO ORDER

Mayor Foy called the meeting to order at 7:00 p.m.

INVOCATION AND PLEDGE OF ALLEGIANCE

Mayor Foy offered the Invocation and led in the Pledge of Allegiance.

ROLL CALL

The Town Administrator called the roll. All members were present with Council Member Withington participating via teleconference call.

COMMENTS FROM THE PUBLIC

None.

APPROVAL OF AGENDA

A motion was made by Vice Mayor Gordon, seconded by Council Member Caranci, and unanimously passed (5-0) to approve the agenda as amended.

APPROVAL OF THE CONSENT AGENDA

Approval of the minutes of the October 8, 2020 and October 22, 2020 Regular Meetings A motion was made by Council Member Withington, seconded by Vice Mayor Gordon, and unanimously passed (5-0) to approve the Consent Agenda as presented.

PROCLAMATIONS AND PRESENTATION

Proclaiming November 15-22, 2020 as National Hunger and Homelessness Awareness Week The Town Administrator offered Staff's report. A motion was made by Council Member Uptegraph, seconded by Vice Mayor Gordon, and unanimously passed (5-0) to approve the Proclamation as presented proclaiming November 15-22, 2020 as National Hunger and Homelessness Awareness Week

COMMENTS FROM THE PALM BEACH COUNTY SHERIFF'S OFFICE

Kayla Schnell, Neighborhood Watch Commander addressed the Town Council. She expressed her concern regarding recent incidents that had occurred within Town. She reported the following:

• October 25, 2020: The homeowner at 5221 Bethany awoke from his sleep to find an intruder standing at the foot of his bed flashing the light of a phone in his face. The intruder fled. It was determined he had gained access into the main house from the garage.

- November 11, 2020: Someone had broken into the garage at 853 Palo Verde and rummaged through the vehicle and stole various items. It was not discovered until the afternoon of the next day.
- November 2, 2020: There was an attempted burglary at 5311 Club Road. The suspect never gained entry after they had shattered the sliding glass door.
- November 16, 2020: There had been a report of a theft at the property at 1146 Palmetto. It turned out the theft resulted from a situation between the landlord and tenant.
- There had been an attempt to steal a vehicle in which the keys had been left inside. a vehicle (address not mentioned).

Council expressed their appreciation to Deputy Schnell as the PBSO.

REGULAR AGENDA AND FIRST READINGS

ORDINANCE NO. 494: AN ORDINANCE OF THE TOWN OF HAVERHILL, FLORIDA, DECLARING ZONING IN PROGRESS AND IMPOSING A MORATORIUM ON THE ACCEPTANCE AND PROCESSING OF NEW APPLICATIONS FOR THE ESTABLISHMENT OF MEDICAL MARIJUANA TREATMENT FACILITIES, INCLUDING DISPENSING FACILITIES, UNTIL JUNE 25, 2021; PROVIDING FOR SEVERABILITY, PROVIDING FOR SCRIVENERS ERRORS; PROVIDING FOR CONFLICTS AND AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

The title was read by Attorney Foster. He offered Staff's report, explaining this was the continuation of an Ordinance prohibiting the establishment of medical marijuana treatment and dispensing facilities within the town. He added that the moratorium would expire June 25, 2021 to coincide with the end of the legislative session, in hopes the legislation would make changes to allow for the municipalities to regulate facilities within their own boundaries.

A motion was then made by Council Member Caranci and seconded by Vice mayor Gordon to pass Ordinance No. 494 on first reading. The vote was called at 4-1, with Council Member Uptegraph voting against the motion.

Approve Change Order No. 1 for Engineering Services for NPDES FDEP Audit

The Town Administrator presented the Town Council with an amendment to the Agreement between the Town and AECOM for NPDES Engineering Services. It was explained by Karen Brandon, Engineer, that the Change Order was for additional engineering services related to the FDEP Audit of the Town's NPDES program. The services, performed based on the hourly rates approved in the original Agreement, were in the amount of \$4,912.50.

Mayor Foy expressed his frustration over the severe fiscal impact the change in audit requirements have had on the Town. He suggested writing a letter to the agency explaining the excessive expense and the financial burden. He also suggested scheduling a ZOOM meeting with the group leader to discuss the recent delegation of responsibilities from the Federal Government, to the State to the County.

A motion was made by Vice Mayor Gordon, seconded by Council Member Uptegraph and unanimously passed (5-0) to approve the change order in the amount of \$4,912.50 and to authorize the Mayor and Staff to draft a letter to the FDEP for Council review and consideration.

Request for waiver from Chapter 38 Section 9 (c) Commercial Vehicles to allow for a commercial vehicle to be parked in the front yard, visible from the road and adjoining

properties, with a GVW of 14,050 lbs. (no lettering) as requested by Bart Rasper, 4581 Charlotte Street.

The Town Administrator presented Staff's report. A discussion followed concerning the intent and distinctions of the recently adopted Ordinance 481.

A motion was made by Vice Mayor Gordon, seconded by Council Member Mark Uptegraph, and unanimously passed (5-0) to raise no objection to granting a waiver from Chapter 38, Section 9 (c) Commercial Vehicles to allow for a commercial vehicle to be parked in the front yard, visible from the street and adjoining properties with a GVW of 14,050 lbs. (no lettering) as requested by the property owner, Bart Rasper.

Council was requested to consider names for appointment so the Council could act on the appointment at their December meeting.

They were oping the Committee could proposed the changes to be placed on the ballot for the November 2021 election.

Town representatives to serve on the Committee would be Vice Mayor Gordon, Council Member Ray Caranci, Town Attorney Foster, and Town Administrator Janice C. Rutan.
