The regular monthly meeting of the Haverhill Town Council was held on Thursday, January 28, 2021 at the Town Hall, 4585 Charlotte Street, Haverhill, Florida. Those present were Jay G. Foy, Mayor; Lawrence Gordon, Vice Mayor; Dennis Withington, Council Member and Ray Caranci, Council Member. Council Member Mark C. Uptegraph, attended via teleconference. John Foster, Town Attorney, Todd McLeod, Town Engineer, and Janice C. Rutan, Town Administrator were also in attendance.

Teleconferencing was available for those persons wanting to participate in the meeting remotely.

CALL TO ORDER

Mayor Foy called the meeting to order at 7:00 p.m.

INVOCATION AND PLEDGE OF ALLEGIANCE

Mayor Foy offered the Invocation and led in the Pledge of Allegiance.

ROLL CALL

The Town Administrator called the roll. All members were present in Council Chambers.

A motion was made by Vice Mayor Gordon, seconded by Council Member Caranci, and unanimously passed (5-0) to approve the agenda as presented.

A motion was made by Council member Uptegraph, seconded by Vice Mayor Gordon, and unanimously passed (5-0) to approve the Consent Agenda as presented.

REGULAR AGENDA AND FIRST READINGS

Discuss Legislative Priorities

Attorney Foster reported that he had been in contact with David Cruz, the FLC Legislative Attorney and was told that there have been no proposed amendments to the

legislation addressing medical marijuana dispensaries. It would be his suggestion that the Town move forward with a ban on medical marijuana dispensaries in the Town. He noted Lake Worth Beach does not allow them within the City.

The Town Administrator would present a draft letter to the Town Council highlighting proposed legislation supported by the Town.

Discuss NPDES Audit Requirements

Mayor Foy led the discussion regarding the continuation of the DEP requiring additional information relating to the annual NPDES Audit. It was his suggestion that the Town reply that they will respond to the outstanding matters in the next fiscal year when costs can be properly budgeted.

Discussion followed. It was suggested the Town Administrator attend a meeting of the NPDES Steering Committee to bring this issue to the forefront and to request the DEP reverse their course of action.

At a minimum, the Town would request an extension to the next budget year to respond to the most recent request for information so it can properly prepare for the fiscal impact of the additional request.

AN ORDINANCE OF THE TOWN COUNCIL OF **ORDINANCE N. 497:** THE TOWN OF HAVERHILL, FLORIDA, CREATING A NEW DIVISION 14, IX, **OF** ARTICLE **MAINTENANCE** STANDARDS, **PROPERTY** SUPPLEMENTAL DISTRICT REGULATIONS, OF CHAPTER 58, ZONING, TO PROVIDE A PURPOSE AND SCOPE, DEFINITIONS, INSPECTION RIGHTS, **APPEARANCE** STANDARDS, ENFORCEMENT, MAINTENANCE AND VACANT LOT MAINTENANCE, AND INOPERATIVE VEHICLES ON PUBLIC PROPERTY; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL FOR CORRECTION CONFLICT: PROVIDING LAWS IN SCRIVENERS' ERRORS; PROVIDING FOR AN EFFECTIVE DATE AND OTHER PURPOSES.

The title was read by Attorney Foster. A very lengthy discussion followed regarding private roads and properties abutting private roads. It was suggested the Town Administrator reach out to Palm Beach County Fire Rescue to determine their roadway specs for private roads. All expressed their concern about the adverse effect on the health, safety and welfare of persons resulting from the excessive parking issues on private streets. Attorney Foster noted that the Fire Prevention was applicable as part of the Building Code.

Mayor Foy brought up his concern about maintaining the safe sight corners. Council member Caranci agreed, adding that he had noticed the digital inclusion pole at the location of Club Road and Haverhill Road seemed to be in the line of the safe corner and hoped it would be corrected during the permitting process and relocated if necessary.

Vice Mayor Gordon commented that the Town Council needed to consider a way to address the maintenance of private roads.

It was agreed that Subsection 584 (e) would be removed from the proposed Ordinance to be discussed at a Code and Ordinance workshop.

Catherine Moore, New Parkview Place. She agreed that something must be done about the parking issues. She reported that when her neighbors have parties, their guests park on her lawn and although against the association rules, there is no one on site to enforce.

With no further discussion, or public comment, a motion was made by Dennis Withington, seconded by Vice Mayor Gordon, and unanimously passed (5-0) to approve Ordinance No. 497, as amended.

The Mayor extended the Local State of Emergency.

Town Administrator

The Town Administrator offered an update on the Briarwood Wall project. The abutting property owners had agreed to the easements and now would be forwarding those easements to their mortgage companies for their consent.

The Town Administrator next requested guidance as to the finishing of the wall and if the Council would be appointing a committee. Consensus to allow staff to recommend beautification to include paint and plantings. The Attorney was concerned about liability if bougainvillea was planted on the backside of the wall.

Committee/Delegate Report

The February 2, 2021 workshop was announced. The Town Administrator reported that Mr. and Mrs. Garcia would be present to discuss Park Lane drainage issues.

Vice Mayor Gordon announced that the Palm Beach County League of Cities would be meeting with the Palm Beach County Legislative Delegation.

Joseph Abruzzo, recently elected Palm Beach County Clerk and Comptroller addressed the January 27, 2021 general meeting of the PBC League of Cities. He reported that property values were holding up very well. He has made some changes within the office and had hired new vendors. Mr. Abruzzo would be available to meet with the Town Council should they wish to invite him to address the residents.

Attorney Foster next reported on the Charter Committee meeting held prior to the Regular Council meeting. He noted that all recommendations would be coming to the Town Council. Items discussed and action taken on included residency requirements; term of office; response to a tie-vote.

Attorney Foster reported that the Committee should finish no later than April, Council to adopt changes by July to be adopted by referendum in November.

The Town Council commented that it would like to control the discussion on run-off election requirements.

Treasurer's Report Included in packet.

UNFINISHED BUSINESS

Discussion followed as to the transition from septic to sewer. Mayor Foy commented that installation of sewer can cost up to five times to cost to install water. All agreed it is something that needs to be looked at. There may be grant funds available. Staff would follow up.
