## TOWN OF HAVERHILL TOWN COUNCIL REGULAR MEETING Thursday, April 22, 2021 OFFICIAL MINUTES

The regular monthly meeting of the Haverhill Town Council was held at the Town Hall, 4585 Charlotte Street on Thursday, April 22, 2021. Those present Jay Foy, Mayor; Lawrence Gordon, Vice Mayor; Dennis Withington, Council Member; Ray Caranci, Council Member and Teresa Johnson, Council Member. Also present were John Fenn Foster, Town Attorney and Janice C. Rutan, Town Administrator.

### CALL TO ORDER

Mayor Foy called the meeting to order at 7:00 p.m.

### INVOCATION AND PLEDGE OF ALLEGIANCE

Mayor Foy offered the invocation and led the Pledge of Allegiance.

#### ROLL CALL

All Town Council Members were present in Council Chambers.

#### COMMENTS FROM THE PUBLIC

### APPROVAL OF AGENDA

The Town Administrator requested that Item C. be removed from the agenda so that prior to Council action, it could be discussed at the upcoming workshop. A motion was made by Council Member Johnson, seconded by Council Member Caranci, and unanimously passed (5-0) to remove Item IX. C. Discuss fee schedule for permits, variations, and waivers from the agenda.

### APPROVAL OF THE CONSENT AGENDA

Approval of the minutes for the February 25, 2021, March 11, 2021 and March 25, 2021 and April 8, 2021 Regular Meetings

A motion was made by Vice Mayor Gordon, seconded by Council Member Withington, and unanimously passed (5-0) to approve the Consent Agenda as presented.

### PROCLAMATIONS AND PRESENTATION

Proclamation recognizing former Council Member Mark C. Uptegraph's years of service Mayor Foy addressed those present. He introduced former Council Member Uptegraph and announced that they were recognizing Council Member Uptegraph for his many years of service given Town on Council. He was grateful to be given the opportunity to thank someone who has been such a stellar representative of the Town.

He then read the Proclamation into the record. He again thanked former Council Member Uptegraph. A photo op followed.

Council Member Johnson spoke. Although she had not worked with former Council Member Uptegraph, she noted his many years of service given to the Town and offered accolades.

Former Council Member Uptegraph and his family thanked the Town Council for the honor and recognition.

### **REGULAR AGENDA AND FIRST READINGS**

### Consider request for reduction of Code Enforcement Lien as requested by Jorge Usma. Property owner at 1021 Cheryl Lane.

The Town Administrator offered Staff's report. She explained that Mr. Usma rents his property on Cheryl Lane. Although he does not live there, that is the address he uses for the Palm Beach Property Appraiser and where his mail is delivered. His notices of violation for parking on the grass had been sent to the Cheryl Lane address. His tenants had not told him about the violations, and when he was made aware, he took care of them immediately and a Notice of Compliance issued. Mr. Usma, through a letter sent to the Town Council, was requesting a reduction of the lien. It was the recommendation of the Code Enforcement officer that the fine be reduced to actual costs incurred by the Town of Haverhill, \$305.00.

A motion was then made by Council Member Johnson, seconded by Council Member Withington, and unanimously passed (5-0) to reduce the lien in the amount of \$1,400. to \$305. resulting in a \$1,095 reduction.

### Review and schedule for Public Hearing proposed Comprehensive Plan Amendment - Evaluation and Appraisal Report (E.A.R.)

The Town Administrator offered Staff's report. She would be moving forward with scheduling the first public hearing of the EAR in May.

### Discuss request for Alternative Sign Plan as filed by Christopher Padgett, Lead Pastor, Abundant Life Church of God

The Town Attorney presented the background of the petition for an alternate sign plan. The Town of Haverhill's sign ordinance does not allow for animated signs. The Town Attorney would like to seek input from the Town Planner before making a Staff recommendation.

Council Member Caranci noted that variances were for the size and measurement of the sign, not for something specifically prohibited.

Paster Chris Padgett of the Abundant Life Church of God addressed the Town Council. He presented the reasons why he would want to install the LED sign. If approved, it would allow him to change his message remotely, digitally, and daily. Although the messages can scroll and change automatically, it was not his intent to flash the sign, but he felt the sign would help himself, his congregation, and the Town for many reasons including those stated above. He offered to meet any parameters the Council wished to impose. He also added that the sign could be used for emergency announcements, time and temperature and messages.

He explained he had been working with Stewart Signs that is one of the largest sign companies installing these type signs for places of worship.

Discussion followed. Vice Mayor Gordon asked about the size of the proposed sign. He also expressed his concern that the placement of this flashing sign would be at the busy intersection of Haverhill and Belvedere Roads, an area already plagued by accidents.

Representatives from Stewart Sign Company were available via teleconference to explain how the signage worked and to answer questions.

The discussion that followed included topics such as improvements to the property, keeping up with technology, etc.

It was agreed that the Town would reach out to other municipalities to determine their regulations relating to animated signs as well as confer with the Town Planner.

### Mayor

The Mayor discussed the continuation of the Emergency Declaration, mask requirements and how the lifting of the declaration would need to be based on facts and science.

### **Town Administrator**

The Town Administrator reported on the proposed Stimulus funding package for the smaller municipalities and that she had received notification from Senator Powell's office that the request for appropriation through the offices of Senator Powell and Representative Willhite had not been coordinated properly for this year's cycle, however, would be ready to file when next year's round opens.

The Town Administrator reported that she and and staff had participated in a seminar on Social Media/Facebook/Instagram/Zoom. It was quite eye opening. Staff would need to make changes in Council Chambers if Council were to move forward in that direction.

Discussion followed. Mayor Foy commented that he participates in zoom/web ex calls several times per week, however, was concerned over the cost for the Town of Haverhill to offer the service. Council Member Withington noted that there was such little participation and felt offering participation through teleconferencing was working fine.

Vice Mayor Gordon noted that the League of Cities uses WebEx as its platform.

Council Member Johnson stated she has used both Zoom and WebEx. She also commented that more residents would most probably participate in meetings if they were available to the public via Zoom or WebEx or any other platform.

The Town Administrator requested Council direction in moving forward as it would entail purchasing a specific version of the software, scheduling staff to attend meetings, etc.

She announced that the Governor was yet to set the date for the Special Election for Seat 20, to fill the unexpired term of Alcee Hastings.

### Committee/Delegate Report

Vice Mayor Gordon announced that the May 26, 2021 Palm Beach County Gala was being planned but would most probably be held virtually.
