The title was read by Attorney Foster. He explained that the proposed Ordinance would afford the Town more options in letting out contracts without having to formally bid the project. Preparing bids to be let out for award was a time-consuming, costly, undertaking for a small municipality and this Ordinance would assist the Town to award contracts that had already been put out through the competitive bidding processes of another governmental entity.

Attorney Foster clarified what would constitute personal property, goods, etc.

A motion was made by Council Member Caranci, seconded by Council Member Johnson, and unanimously passed (4-0) to approve Ordinance No. 508 on first reading.
