

BUSINESS IMPACT ESTIMATE

PROPOSED ORDINANCE NO. 538

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF HAVERHILL, PALM BEACH COUNTY, FLORIDA, AMENDING DIVISION 10, CONGREGATE LIVING FACILITIES, OF ARTICLE IX, SUPPLEMENTAL DISTRICT REGULATIONS, OF CHAPTER 58, ZONING, BY CREATING A NEW SECTION 58-492, CERTIFIED RECOVERY RESIDENCE, TO ESTABLISH PROCEDURES FOR THE REVIEW AND APPROVAL OF CERTIFIED RECOVERY RESIDENCES THAT INCLUDE A WRITTEN APPLICATION PROCESS FOR REQUESTING REASONABLE ACCOMMODATIONS FROM ANY LOCAL LAND USE REGULATION THAT SERVES TO PROHIBIT THE ESTABLISHMENT OF A CERTIFIED RECOVERY RESIDENCE AND THAT REQUIRE THE TOWN TO NOTIFY ANY APPLICANT OF WITHIN THIRTY (30) DAYS OF RECEIPT OF AN APPLICATION IF ADDITIONAL INFORMATION IS REQUIRED AND ALLOWING AN APPLICANT AT LEAST THIRTY (30) DAYS TO RESPOND; REQUIRING THE TOWN TO ISSUE A FINAL WRITTEN DETERMINATION WITHIN SIXTY (60) DAYS AFTER RECEIPT OF A COMPLETED APPLICATION OR THE REQUEST SHALL BE DEEMED APPROVED; ADDING A DEFINITION OF CERTIFIED RECOVERY RESIDENCE; PRESCRIBING THE MINIMUM INFORMATION TO BE CONTAINED WITHIN ANY APPLICATION; REQUIRING CONSISTENCY WITH THE FAIR HOUSING AMENDMENTS ACT OF 1988, 42 U.S.C. SS. 3601 ET. SEQ., AND TITLE II OF THE AMERICANS WITH DISABILITIES ACT, 42 U.S.C. SS 12131 ET SEO.; PROVIDING FOR REPEAL OF LAWS IN CONFLICT; PROVIDING FOR CORRECTION OF SCRIVENERS' ERRORS; PROVIDING FOR CODIFICATION, AN EFFECTIVE DATE AND OTHER PURPOSES.
