

## **BUSINESS IMPACT ESTIMATE**

## PROPOSED ORDINANCE NO. 535

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF HAVERHILL, PALM BEACH COUNTY, FLORIDA, AMENDING SECTION 38-9, PARKING OF MOTOR VEHICLES, RECREATIONAL VEHICLES, WATERCRAFT AND TRAILERS IN RESIDENTIAL DISTRICT, OF CHAPTER 38, TRAFFIC AND VEHICLES, OF THE CODE OF ORDINANCES OF THE TOWN OF HAVERHILL, BY CLARIFYING IN SUBSECTION (d)(2)(ii)(4) THAT ALL RECREATIONAL VEHICLES SHALL BE STORED WITH ALL SLIDE-OUTS AND AWNINGS IN THE CLOSED POSITION; PROVIDING FOR REPEAL OF LAWS IN CONFLICT; PROVIDING FOR CORRECTION OF SCRIVENERS' ERRORS; PROVIDING FOR CODIFICATION, AN EFFECTIVE DATE AND OTHER PURPOSES.

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes, and may be revised following its initial posting.

- 1. A summary of the proposed ordinance (must include a statement of public purpose, such as serving the public health, safety, morals and welfare):

The Town Council of the Town of Haverhill, as the governing body of the Town of Haverhill, pursuant to the authority vested in Chapter 166, Florida Statutes, and the Charter of the Town of Haverhill, is authorized and empowered to provide for matters of safety relating to parking of recreational vehicles in residential areas; and therefore desires via this proposed ordinance to make a clarification to Chapter 38 by clarifying that all recreational vehicles shall be stored with all slide-outs and awnings in the closed position; more specifically to provide for safe and efficient septic systems within the Town that can become overwhelmed by overcrowding on a residential lot.
